Everything we buy in stores usually has a long way behind it. And some price wars are literally fought on the backs of many people.

Currently, an effective supply chain law for the EU is being discussed.

As Evangelical-Lutheran Youth in Bavaria, it is important to us that human rights and environmental protection are guaranteed everywhere in supply chains. That is why we are campaigning for a strong supply chain law.

With our action we want to symbolically spread the demand for an effective supply chain law in the EU.

How the campaign works

Together we want to bring the contents and the idea of an effective supply chain law to every capital of the EU. For this we symbolically "run" the distance from Pappenheim to each capital, in total it is about 26,500 kilometers.

It is unimaginable for one person or even for a group to run this distance just like that and especially during the daily routine. That's why we want to tackle it together. We need every group, every individual and especially you. **Whether as a group or alone, whether on the bike, in the water or on the bouldering wall, every kilometre brings us closer to our goal.**

Biking, running, hiking can be measured in kilometres. With us you can also collect kilometres with other forms of movement (e.g. dancing, trampolining, yoga, ...). The following conversion factor applies: **5 minutes extra movement = 1 kilometre!**

Join us and register your distance during the campaign period from October 17 to November 20, 2022 and become part of a movement for fairer supply chains!
